Station 84 is being used by the City of Crestview while their station is having repairs done. The timeline is 30-90 days.

Chief McMaster brought a quote from Jobe's Dirt Works to the board for removal of bldg. 1 at Station 81. They gave pricing on just removing the building for \$12,500.00 and the other for the building and the slab for \$17,500.00.
